1. Premier Mortgage Service Limited (trading as PMS, "PMS") has negotiated and agreed advantageous products, commission rates, services and exclusive protection products with the protection product provider on Solo (the "Services"). By completing this Application Form and joining our protection propositions you can access the Services, which are available via:
 - i. Pipeline;
 - ii. Provider extranet provided by the protection product provider; and
 - iii. Other distribution channels that we may communicate to you from time to time.
2. You shall submit at least 85% of your company's protection business through Solo, unless client circumstances or the FCA Handbook requires otherwise. Without prejudice to the generality of clause 8 in these short form terms and conditions, PMS reserves the right to remove your access to the Services if you fail to comply with this clause 2.
3. Before you can submit any business to the protection product provider, you will be required to enter into separate terms of business with that protection product provider. This separate terms of business will govern your relationship with the protection product provider and you are required to adhere to them.
4. You agree that PMS can receive payments that may be classed as commission from the protection provider directly. You pass on the right to receive said commission to PMS. You must disclose the gross commission paid by protection product providers.
5. You will receive 95% of the gross commission paid by the protection product provider arising out of business written by you under the Solo proposition, with PMS receiving the remaining 5%.
6. You agree that we may share data (including commissions earnings data) about your firm, your advisers and the business which you have transacted using the Services with the protection product provider under Solo, sourcing system providers and other Sesame Bankhall Group companies for administration purposes.
7. You will authorise PMS to obtain and receive data from the product provider under Solo to verify the levels of business submitted by your company through Solo and you shall take any reasonable action required by PMS to enable PMS to receive such data.
8. Your liability to repay commission ("Clawback") will be in direct proportion to the percentage of commission you have received (e.g. you will be liable for 95% of the Clawback and PMS will be liable for the remaining 5%).
9. PMS reserves the right to remove your access to the Services at any time.
10. These short form terms and conditions only govern your access to the Services and business written by you arising out of such Services. Any other services provided by PMS will be governed by separate agreement.
